For Authors:

All manuscripts for articles, original research reports, editorials, and letters that are submitted to the journal Annals of Postgraduate Medical Science must be accompanied by a conflict of interest disclosure statement or a declaration by the authors that they do not have any conflicts of interest to declare.

Conflicts of interest for given manuscript exist when one or more author has ties to activities that could inappropriately influence his or her judgment, whether or not judgment is in fact affected. Financial relationship with industry (throught investments, employment consultancies, stock owner, pharmaceutical companies, or foundations supported by entities that could be perceived to have a financial stake in the outcome). This support may include board memberships, consultancies, employment, expert testimony, grants, speaker's bureaus, payment for manuscript preparation, patents, royalties, creation of educational pieces, stocks, stock options, and other support.

To facilitate this policy, all authors must privately disclose "ALL their potential conflicts of interest" to the editors of the journal at the time of submission. These include all financial and non-financial interests and relationships (see definitions provided a little later in the text), direct employment with a private sector entity (whether full or part-time), and service on private sector and non-profit Boards and advisory panels, whether paid or unpaid.

Authors should also disclose any conflict of interest that may have influenced either the conduct or the presentation of the research to the editors, including but not limited to close relationships with those who might be helped or hurt by the publication, academic interests and rivalries, and any personal, religious or political convictions relevant to the topic at hand. In the article, the authors must include a draft statement that discloses all relevant conflicts of interest and affiliations.

In case of a potential conflict of interest, the information must be provided to the Publisher during online submission process (Editorial System).
